NHA shall review its retention of such data on a 10 year basis and NHA shall not sell or rent your information to any third parties.

NHA may pass your information to third party providers including, but not limited to: actors, subcontractors and other associated organisations for the purposes of providing our services to you. However, when we use third party service providers, we shall only disclose the information that is essential to deliver our service. NHA shall never release
